HOW TO CLEAN

Disinfection

To disinfect inanimate, hard, non-porous surfaces use the appropriate-sized premeasured packet.

Small	0.1023 ounce	1	Quart	1552

- Insert entire Pac into bottle (Do not cut or tear Pac open)
- 2. Fill bottle with cool or warm water
- 3. Wait approximately 1 minute, then gently shake
- 4. Apply solution with hand-pump trigger sprayer so as to wet all surfaces thoroughly
- Allow to remain wet for 10 minutes, then remove excess liquid

General Cleaning & Deodorization

Apply product to soiled area with hand pump trigger sprayer. Product must be diluted as indicated in the DISINFECTION section. Thoroughly wet soiled surface and scrub as necessary. Rinse surface with potable water and wipe dry.

These products do NOT replace a full facility/business decontamination.
